Release of Student Information to Military Recruiters, College/University Recruiters or Prospective Employers Notification

Dear Parent/Guardian:

The Elementary and Secondary Education Act (ESEA), as amended by the Every Student Succeeds Act (ESSA), requires local educational agencies (LEAs) receiving assistance under ESEA, upon request, to provide certain student information to military recruiters, institutions of higher education, and/or prospective employers [ESEA Section 8528].

ESEA Section 8528 outlines provisions that give military recruiters the same access to secondary school students as recruiters from postsecondary institutions or prospective employers and, when requested, requires LEAs to provide students' names, email addresses, addresses, and telephone numbers to military recruiters. The Trenton Public School District must provide this information unless a parent of a student who is younger than 18 years of age, or a student who is age 18 or over, opts out by notifying the school in writing that they do not consent to release this information.

If your child is younger than 18, and you **do not consent** to the disclosure of this information, you must complete, sign, and return the attached nondisclosure form (Attachment A) to the Supervisor of Guidance & Assessment, Linda Wyatt-Simpson lwyatt-simpson@trenton.k12.nj.us. If your child is 18 years of age or older, they determine whether to consent to release the information, and they complete, sign, and return the attached form to the Supervisor of Guidance & Assessment, Linda Wyatt-Simpson@trenton.k12.nj.us. If the nondisclosure form is not returned, your child's information will be released upon request.
